The purpose of this contract is to protect all parties, the purchaser, seller and the animal. We want new owners to be completely happy with their kitten/cat. If you have any questions or concerns please contact Janne, I am happy to help if I can.

Terms of Contract

Deposit; A non refundable deposit of \$__400.00____ is required to secure a kitten/cat. This deposit will be assumed to be a commitment to purchase said animal. Should the purchaser, after having paid the deposit decide against buying the kitten, the deposit will be forfeited. The animal will be reserved for 7 days after purchaser has agreed to pay holding deposit, if deposit is not received within 7 days the reservation will cease. The deposit is deducted from purchase price. *

Deposits and balance owing on kitten can be made in cash or internet banking.

The seller agrees to purchaser discussing the kitten/cat's health information, sterilization status with purchaser's veterinarian. *

Kittens and cats will be desexed before leaving at seller's expense except in exceptional circumstances in which case a seperate Desexing Contract will apply, requiring that kitten is desexed within a specified time frame, at purchaser's expense. Seller will deduct price of desexing (price quoted to seller by Franklin Vets) When proof is received that animal has been desexed, registered ownership will be transferred from seller to purchaser. If purchaser has not had kitten desexed within the specified time, the kitten will remain registered as owned by the seller and legal proceedings may ensue. *

Kittens will be desexed, microchipped and will have received at least 1st vaccination. They will have had a health clearance from vet prior to leaving at which time they are guaranteed to be symptom free and parasite free for 48 hours after arrival. Viruses, bacterial infections and parasites can affect the animal in it's new environment. Under no circumstances will seller be responsible for any vets bills incurred by the purchaser. *

The seller guarantees the animal against lethal genetic or congenital defects for 6 months following purchase date. If during these 6 months the cat should die or have been euthanased due to a genetic or congenital defect, the seller will replace kitten/cat with another at seller's earliest convenience, provided following conditions are met;

Purchaser provides seller with a necropsy report by licensed veterinary

pathologist at purchaser's expense, stating cause of death is unquestionably a genetic or congenital defect. Purchaser must allow information regarding the animals necropsy report to be discussed freely between their vet and Seller's vet. Seller may require a second examination by vet of seller's choice to corroborate any claims.*

Purchaser is responsible for all travel expenses, and if seller takes kitten/cat to airport mileage will be charged . *
